- To raise funds or acquires assets, by accepting donation, gifts, grants, aid and other contributions, for all of any of the objects of the Trust. from any person, institution, Government, Trust, Corporation, or Association etc.
- ii. To publish literature and periodicals for the purpose of information and education.
- iii. To enter any agreement or arrangement with any person or corporation in furtherance of the objects of the Trust. directly or indirectly, provided however, that no charge, lien, mortgage, or any form of encumbrance whatsoever, shall be created in respects of any of the Assets in furtherance or any or the aforesaid objects of the Trust.
- iv. To apply to any appropriate authority for the sanction and grant of loans / lands on lease or otherwise and/ or any other benefits in any part of India, as may be necessary to establish/ maintain canters for the furtherance and attainment of the objects specified above.

Provide, however, that the entire income from the properties held for the Trust, and all donation and monies received towards the corpus of the Trust, shall be used strictly and exclusively for the benefit of the public at large and for the objects of the Trust, no activity shall be carried out for any motive or profit whatsoever.

CONSTITUTION OF THE TRUST:

- i. There will be a Board namely "BOARD OF TRUSTEE'S" in which all the Trustees will be included.
- ii. The SETTLER/ TRUSTEE Shri AWINASH TIWARI shall be chairman cum Managing Trustee for life, unless he resign, All the Trustees including the SETTLER who have signed this DEED shall be life long Trustee unless they resign.
- iii. Every Trustee who have signed this DEED will be entitled to nominate their Successor during their life time. Every trustee so nominated will be entitled to act

as Trustee after the death of the Trustee who has nominated him as Trustee. The vacancy in the office of chairman cum manageing trustee, shall be the filled by the express resolution of the TRUSTEES who have signed this DEED or their successor nominated. It is made clear that the chairman cum managing Trustee will be from the 'TRUSTEES' who have signed this DEED or their successor nominated.

- iv. The minimum number of 'TRUSTEES' constituting the Board of TRUSTEES shall be Five including the Chairman cum Managing Trustee or their nominee bu. Shall never exceed Fifteen (15). If necessary, the special invite ex. office member may be nominated accordingly, but their has no voting power.
- v. The Chairman Cum Managing Trustee may appoint Trustee as secretary and delegate by express resolution such function an authorities to him/her as he may deem fit and revoke the same, wholly or in part as he may deem fit in his absolute discretion.
- vi. All account books, records title-deeds, other document relating to the properties of the Trust, shall remain in the custody of the Chairman Cum Managing Trustee for the time being; or any other person appointed by him for such custody, provided, however, that in the event of vacancy to the office of the Chairman cum Managing trustee. if any, the said books, records, documents, negotiable instruments, shall be delivered up to the successor-in-office, by any person in possession of or having custody of the same.

DUTIES AND FUNCTIONS OF TRUSTEE (S)

The Trustees shall have the following functions, and shall undertake the duties as set out below:



- 1. The Chairman cum managing trustee in consultation with the other Trustee(s) shall have the power to buy, erect, construct, sell or otherwise dispose of lands, building, workshop or any other property of assets, and to demolish or alter the same in any manner provided that the Chairman cum Managing Trustee or his successor -inoffice shall always act in the best interests of the Trust and shall; not exercise his powers to the detriment and prejudice of the Trust.
- 2. The Chairman cum managing Trustee in consolation with the other Trustee(s), allot, from time to time, funds for any one or more of the various objects of the Trust, and may in his absolute discretion, allot funds for any one or more of the above objects;
- 3. The Trustee may accept any donation or contribution in case or kind, form any person, firm, company, corporation association, institution or trust, or upon such terms and conditions as they may in their absolute discretion think fit provide however, that they are not inconsistent with the object or the objects of the Trustees, The Trustee, may take over the Management of any other Trust public Institution on such terms as they think fit to manage them; .
- 4. The Trustees shall invest or deposit the Corpus funds of the Trust and the income derived there from strictly in accordance with the provisions relating to public Charitable Trusts in the Indian Income Tax Act. 1961 & FCRA 1976.
- 5. The surplus funds of the Trust shall be invested as provided in the Indian Income Tax Act. 1961 / FCRA 1976 as amended from time to time.
- 6. Without prejudice to any of the power of the Trustees set out in this Deed, the Trustees shall have the power, at any time and from time to time, to expend any part of the Corpus of Trust, and property, for any one or more of the objects of the Trust provided however, that such expenditure is incurred with the concurrence of the Chairman Cum Managing Trustee during his life-time and thereafter by consent in 3-114 ment doubl

7. The Chairman Cum Managing Trustee in consultation with other Trustee (s) shall have full power to enter into contracts for carrying out the object of the Trust and to employ contractors or experts or execute such work departmentally and to suspend or dismiss any one of them on such terms and conditions as maybe considered appropriate and to do all other acts and things, incidents to or connected with the furtherance of the objects of the Trust or any one of them;

8. The trustees may hold any of the properties of the Trust, in the names of he trust, or where, under any law, the property cannot be held in the name of the Trust, then it shall be held in the name of any trustee(s) who shall hold the same for and on behalf

of the Trust;

9. If the income from the property of the Trust in a particular year is not fully utilized the accumulated income shall be carried over to the next year(s) and spent in such subsequent years (s) for the advancement of any of the objects of the Trust, subject to the relevant provisions of the Income Tax Act 1961.

10. The Chairmen Cum Managing Trust in consultation with the other Trustee(s) may demise any immovable property or properties for the time being and from time to time, belonging to the Trustee, either from year to year or for any fixed term or for any term of years or on monthly tenancies, at such rent and subject to such covenants and conditions as they may think proper and accept surrenders of leases and tenancies and generally manage the same in such manner as they think proper.


11. The chairman Cum Managing Trust in consultation with the other Trustee(s) shall have full power to compromise or compound all actions, suits and other proceeding including arbitrations and Chairman Cum Managing Trust differences and disputes connected with, touching or arising out the properties or estates of the Trust, and do

all other acts and things fully and effectually without being liable or answerable for any bonafide loss occasioned thereby.

- 12 The Chairman Cum Managing Trust and the others Trustee(s) may from time to time frame schemes, Rules and Regulations to carry out the objects of the Trust and for managing the affair of the Trust and for otherwise giving effect to the objects and purposes of the Trust and to vary the same from time to time as they may in their discretion deem fit and proper.
- 13 The Board of trustee may reimburse themselves and pay and discharge out of the corpus of the Trust, all; expenses incurred by them in or about the execution of the Trust or any of their duties and function under these presents, incusing traveling expenses and the like, but will not be entitled to any remuneration'
- 14 Any Trustee may resign at any time without assigning any reason and without being responsible for any costs occasioned by such retirement.
- 15 The Surviving or continuing Trustee(s) may, notwithstanding any vacancy in the Board of the Trustees act as the Board of Trustees, provide, however, that if the number of Trustees fails below Five minimum fixed by these presents, the remaining Trustees shall not expect for the purpose of filling up the vacancy, act so long as number is below the said minimum'
- 16 Five Trustees at a meeting of the Board of Trustees shall from a quorum for any meeting of the Board of Trustees.
- 17 The Chairmen Cum Managing Trust or his successor-in-office or anyone, so expressly appointed for a particular meeting by the Chairman Cum Managing Trust or his successor-in-office shall act as the Chairman of the meetings of the Board or Trustees, or any sub committees(s) thereon:
- Trustees shall be decided by a majority or votes, and inc case of an quality or votes, the Chairman Cum Managing Trustee shall have a second or casting vote, provided, however, that notwithstanding anything herein stated no questions dealing with the disposal of the corpus of any of the properties of the Trust and/or investment of the corpus of any of the Trust shall be decided except with the express consent of the Chairman Cum Managing Trust of the Trust or his successor-in-officer.
- In case of a difference in opinion between the Trustees, the opinion of the majority shall prevail, and if the Trustee are equally divided in any matter the Chairman Cum Managing Trustee of the trust shall have a casting vote;





- A resolution in writing circulated amongst all the member of the Board of Trustee and signed by a majority of the Trustees shall be as shall be as valid and effectual as if it had been passed at a meeting of the Board or Trustee, duly called and convened;
- 21 Notice of ac meeting of the Board or Trustees and all communication may be sent to the Trustees at their respective addresses registered for the time being in the records of the Trust. The period of notice for the meeting of Board of Trustees shall be (15) Fifteen days clear days.
 - 22 All meeting of the Board of Trustees shall be held at such place and such timec as time Chairman Cum Managing Trust or the Trust shall decide from time to time.
 - 23 The minutes of the proceeding of every meeting of the Board of Trustees shall be entered in a book to be kept for such purpose, and signed by the Chairman Cum Managing Trustee of such meeting or of the following meeting when they are red signed by the Chairmen Cum Managing Trustee of such meeting or of the following meeting when they are read over and shall when so entered and signed be conculsive evidence of the business transacted at such meeting.

24 No Persons being;

- I. An undercharge insolvent or
- II. Convicted of an offence involving moral turpitude or
- III. Of unsound mind,

Shall be eligible to be a Trustee, provided, however, that minor may a Trustee, where his guardian in there to protect the miner's legal interest and conduct legal transactions on his behalf.

The power to appoint new or additional Trustees, but so as not to exceed the maximum number of Fifteen and to fill vacancies in the office of Board of Trustees, shall vest in the Chairman Cum Managing Trust or his successor-in-office and where the Chairman's for the time being is a minor he/she could act through his her guardian The tenure of such new or additional trustee shall be fixed by chairmen Cum Managing Trustee with the consultation of the trustees whose tenure is for life or their successor.
- 26. A person shall cease to be Trustee in any of the following events.
 - a. If he dies; or





- b. If he become bankrupt;
- c. If the become insane otherwise become incapable of acting; or
- d. If the resigns from his office;
- The Chairman Cum Managing Trustee in consultation with the other Trustees have the power in relation to appointment, termination, removal of the Trustee(s) officer's employees, etc.
- There shall be an Annual General Meeting of the Board of Trustees, but any number of other meeting maybe convened by the Chairman Cum Managing Trustee as and when considered necessary;
- On a new additional Trustee(s) being appointed, an on his/her/their accepting the appointment, the property of the Trust shall automatically vest in him /her/ them, along with the other Trustee(s) for the time being and him/she/they will be entitled to carry out the duties and function of the Trustee without any other deed or witting;
- The Board of Trustee shall be entitled to sue, with the consent of the Chairman Cum Managing Trustee in writing in the name of the Trust and may similarly be sued in the name of the Trust, and the suits or defence will be conducted in the name of the person authorize by the Chairman Cum Managing Trustee of the Board of Trustees for in writing in whose signature suits and defenses, will be filled in the court concerned or any other forum.
- The Board of Trustees shall have accounts of the Trust audited annually by a person(s) duly qualified to be an Auditor, under the Companies Act, 1956.
- Thee Trust shall be competent to open Bank Accounts in any one or more Bank's may be decide by the Board of Trustees from time to time. Every sum of money received on account of the Trust, shall be deposited to the Credit of the Trust's accounts in any one of the said Banks unless otherwise expressly provided in the Rule or by the Chairman Cum Managing Trustee or his successor-in-office unless the chairman or his successor-in-office directors otherwise in writing, the Bank account will be operated by Chairman Cum Managing Trustee.
- Without affecting the generality of the powers of the Trust to manage and administer its affairs, The board of Trustees Shall have the following function.
 - i. The arrange for and/or to authorize the signing or execution of any agreement, contract, instrument, document, or any other paper in writing, required to be signed or executed on behalf of the Trust. Besides the Chairman or his



nominee or his successor-in-office, no other Trustee shall be entitled to execute such agreements documents, unless, so expressly authorized. Such agreement/document shall become effective as provide therein, if the Chairman Cum Managing Trust or his successor-in- office or nominee shall sign and execute the same.

- ii. To appointed or make provisions for the appointment of a sub-committee of Trustee(s) to attend to or supervise or conduct specific duties or functions or matters relating to the Trust in such manner and subject to such Rules and Regulation, if any, as the Board of Trustees may prescribe, subject to the consent of the Chairman Cum Managing Trust his successor-in-office.
- iii. To Spend any portion of the Corpus the income of the Trust's fund for purchasing any land/or constructing any building (s) for and in the same of Trust, for the purpose of carrying out, promotion and or executing any or all the object of the Trust, provided however that the Chairman Cum Managing Trustee or his successor –in-office for the time being shall so consent in writing.
- 34. That the Chairman Cum Managing Trustee shall delegate such powers deemed necessary by an express resolution in writing, authorizing the any Managing Trustee or secretary nominee to incur such expenditure as may be necessary for the furtherance of any of the Trust as also the non-recurring, total expenditure for the furtherance of any of the Trust as also the non-recurring, recurring, total necessary, the Chairman, Cum Managing Trustee shall by resolution authorize the any Trustee therein to operate the Bank Account and draw from the same such amounts, as may be necessary for the purposes specified above, on behalf of the Trust and for the purpose and objects of the Trust as set out in the present Deed. The said operation of the Accounts and withdrawals will be conducted by the Secretary nominated of the Board of Trustees.
- 35. The Chairman Cum Managing Trust in consultation with the other Trustee(s) frame such Rules and Regulations as may be necessary for conduct of residents at all of the Centers of the present Trust. The Chainman Cum managing Trust shall be at liberty to amend the Rules and Regulations as may be necessary for the purpose of maintenance of order and discipline at any or all of the Centers of the present Trust;
- 36. The Chairman Cum Managing Trust appoint Secretary Trustee herein with consultation of Trustees who have signed this deed delegate such function such function and authorities to her/him as he may deem. fit, and revoke the same, wholly or in part as he may deem fit in his absolute discretion;





- 37. That the assets of the Trust including its nominees, properties ets, shall be applied only for the attainment of the objects set in the present Deed not for the purpose of any business or activity unrelated to the objects of the present Trust. Further, no charge, lien, any of the assets including properties, monies etc.
- 38. That the period of the notice for any special meeting of the Board of Trustees or tranction urgent business shall be seven clear days.

MISCELLANEOUS PROVISIONAL:

- 1- The closing of the accounts of the Trust shall be the 31st March of each year.]
- 2- If any of the Objects mentioned above, are found to be outside the scope of the Income-tax- Act. 1961 and Foreign Contribution Regulation Act. 1976 or any Amendment there of, as may be in force at the relevant time or if they contravene the provisions of any other law relating to Charitable Trust, the Chairman may delete the same or any part there of from the objects of the Trust;
- 3- In case of any of the objects are found be absolutely impossible or invalid for any reason, including being vague, or for any other cause become invalid or impossible, subject to any subsequent legislation or otherwise, such object(s) shall be deemed not be have been included in the objects of the Trust, This shall not effect the validity of the Trust, or the continuance of the, Trust, for the fulfillment of the reaming objects in any manner whatsoever;
- 4- In case of failure of the Trust for want objects, the Chairman Cum Managing Trust or his successor- in-office may move the court for Amendment of any or the objects or the Trust, if found necessary;
- 5- No Trustee shall be liable for any loss of the Trust's funds or properties, unless it has been caused due to his/'her/ their gross negligence, or the Trustee himself/herself/ themselves are guilty of fraud, misfeasance, embezzlement, breach of trust etc.
- 6- No Part, of the Trust's fund or income there from shall be utilized for any other object than that of he Trust hereby create;
- 7- No Trustee shall be paid any fee or remuration except conveyance, traveling or other out- or-pocket expenses incurred by him/ her ins connection with any works for and on behalf of the Trust, or except as otherwise provided in this Trust.
- 8- The Chairman Cum Managing Trustee may appoint one of the Trustees to devote a substantial part of his/her time to the work, of the Trust. Further the Chairman Cum Managing Trust may in his discretion appoint, a full-time Derector, being, other than,

- a Trustee, at such term and conditions as may be decieded upon by him in consultation with the other Trustees;
- 9- The Chairman Cum Managing Trustee in his life time and his successor-in-office thereafter may in his sole discretion, absorb any other Trust, Society or institution having similar to the objects of the present Trust, or amalgamate the present Trust with any other Trust, Society or Institution having similar objects;
 - 10- In the event or the Trust being would up the corpus funds of the Trust, Including its other assets, shall stand transferred to any other Trust, Society or institution or public organization created for the promotion of object similar to the present Trust, subject to the decision of the Chairman Cum Managing Trustee or his successor-in- office
 - 11-The income of the Trust shall be strictly applied to the objects enumerated above and no part of it shall be applied to any objects outside the present Trust, or beyond the Schedule as Contained in the Indian Income Tax Act 1961
 - 12-The Income of the Trust shall not be accumulated excepts to the extent as may be permissible under the Income Tax Act 1961/FCRA 1976.
 - 13-For the Purpose of assessing the Stamp Duty the value of the Trust property is assessed at Rs. 5000/- (Ruppes Five Thousand only)
 - 14-The Board of Trustee shall have the power to amend the present Trust, so that the objects of the Trust may be more effectually attained.
 - 15-The Trustee shall be entitled to event new building and assets and properties of the trust in full or part there of exchange the same for equality or exchange and deal in any manner as they think fit and proper in interest of the trust.
 - 16- The trustee may appoint paid or honorary secretary or manager and other officers and staff, including social and educational to manage, run and administer the trust and to carry out the correspondence and other business on behalf of the trust, as may be necessary and to pay their remuneration.
 - 17-In the event of any dispute between the trustees regarding, trusts property and its management, no person is entitled to file any suit in any court. If any dispute arise for the arbitratior shall be appointed or nominated by the all the trustees and the chairman Cum Managing Trust.
 - 18-The Trustees may within the basic structure of this deed framed, alter add, substitute any clause in the inluist of the trust.
